## 2019 Residential Franchise Report

While the great majority of real estate brokerages are independent firms, the impact of franchise companies remains unmistakable. A full 42% of REALTORS® are affiliated with a franchise, according to NAR data. Here's a rundown of 28 franchise brands, from Century 21, which began franchising in 1971, to Pink Realty, which launched last year. If you're thinking about opening a franchise or affiliating with a national or regional brand, this chart can help you compare offerings. You'll find information about the companies' U.S. market presence, changes in size from two years ago, and fee structure.
