Selecting a Lending Institution (Mortgages &/or Loans)

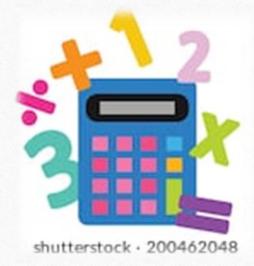
Why does it matter?

- Customer Service and Support from the Loan Officer to the Processors and Underwriters
- Diversity of Loan Programs
- Financial Calculator Apps online banking, mortgage app, calculator
- Familiarity with the people you are working



Selecting a Financial Institution

(Banks ~ For Profit & Credit Unions ~ Not for Profit)

Why does it matter?

What should I ask?

How will it help me?

Services and Benefits to look for in a financial institution?

- Customer Service and Support
- Checking/Savings/Money Market
- Business Account Management/Credit Card
- Electronic Funds Transfer(EFT) Fees and Apps
- On-line Only or Brick & Mortar as well



How often should I visit (if Brick & Mortar)?

- Frequently enough to be familiar by face (maybe even by name)
- Trying to Establish connections with Reception, Tellers, Personal Bankers
- To do something you would usually ask Google, Siri, Alexa
 - Rates
 - Routing Numbers
 - App usage



Working with a Private Banker

- Can my credit score affect my ability to borrow or qualify?
- Are they affiliated with my lender's entity or a third party?
 - Should I ask how they are compensated?
 - Do I get anything in return?
- Is it common to get notified of a special offering or service?
 - Example If I want to apply for the next round of PPP funding; is it common for them to reach out to me? If not, how can I build that relationship?

Selecting a Financial Planner (Retirement & Investing)

Why does it matter?

What should I ask?

How will it help me?

Important Questions to Ask?!

- What should I look for in terms of their experience, background and track record?
- What fees do I pay/incur?
- Will they take my risk tolerance into consideration?
- What certifications should I be looking for?
- Should I get a written agreement outlining services and the fees?
