<p><b>March 1 – May 15, 2024</b></p>	<ul style="list-style-type: none"> <li>• Committee Application Website opens on March 1.</li> <li>• Members complete/update their Expertise Profiles.</li> <li>• Members submit a committee application for up to five (5) committees and seek up to three (3) endorsements per application.</li> <li>• Members submit endorsements for applicants.</li> </ul>
<p><b>May 15, 2024</b></p>	<p><b>DEADLINE:</b> Committee Application Website closes.</p> <p><i>NOTE: 2024 RLM in DC is May 4-9, 2024. Application period is open during RLM to maximize opportunity to encourage members to apply.</i></p>
<p><b>May 16 – May 30, 2024</b></p>	<p>Window opens for:</p> <ul style="list-style-type: none"> <li>• State AEs to recommend members for their state representative positions on committees.</li> <li>• State Associations to review and rank committee applications for members within their state.</li> <li>• Institute, Societies, and Councils (ISC) EVPs to recommend members for their ISC representative positions on committees.</li> <li>• Multicultural Partners to recommend members for representative positions on committees.</li> </ul>
<p><b>June 26, 2024 (TENTATIVE)</b></p>	<p>Appointment notifications for chairs and vice chairs are emailed.</p>
<p><b>July 31, 2024</b></p>	<p>NAR Director allocations determined using membership numbers.</p>
<p><b>August 1, 2024</b></p>	<p>Director submissions website opens.</p>
<p><b>August 26-27, 2024</b></p>	<p>Leadership Summit &amp; Camp training in Chicago, IL for selected 2025 Chairs and Vice Chairs, committee liaisons and staff executives.</p>
<p><b>September 2-15, 2024</b></p>	<p>Window open for State Associations AEs, ISCs EVPs, and Multicultural Partner directors to review preliminary committee appointments for all members within their organization.</p>
<p><b>September 15, 2024</b></p>	<p><b>DEADLINE:</b> State associations and local boards submit director(s) names for director entitlement allocations. <u>Failure to submit names on this date results in the association’s forfeiture of the allocated director seat.</u></p>
<p><b>October 1, 2024 (TENTATIVE)</b></p>	<p>2025 Committee Appointments are announced via email.</p>
